### General Conditions

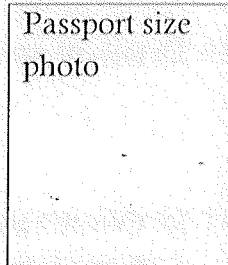
1. The provisions in the Kerala State Electricity Regulatory Commission (Appointment of Consultants) Regulations, 2015, as amended from time to time shall be applicable.
