# **NOTIFICATION**

As per Regulation 10 (2) of Kerala State Electricity Regulatory Commission (Consumer Grievance Redressal Forum and Electricity Ombudsman) Regulations, 2023, a licensee may establish a required number of Fora so as to ensure that any consumer in the area of supply of the licensee shall not have to travel more than about 100 km to submit his complaint/grievance with the Forum for redressal. The concentration of the consumer in a particular area and the number of complaints, likely to be received and the constraints of the Forum in disposing of the complaints, within the stipulated time frame may also be taken into account, while fixing the location of the Consumer Grievance Redressal Forum (CGRF).

The following CGRFs are functioning in the State of Kerala.

- 1) CGRF (South), KSEB Ltd, Kottarakkara-Head Quarters at Kottarakkara.
- 2) CGRF (Central), KSEB Ltd, Ernakulam- Head Quarters at Kalamassery.
- 3) CGRF (North), KSEB Ltd, Kozhikode-Head Quarters at Kozhikode.
- 4) CGRF, Thrissur Corporation Electricity Department (TCED)- Head Quarters at Thrissur.
- 5) CGRF, Technopark, Kazhakottom, Head Quarters at Thiruvananthapuram.
- 6) CGRF, Kannan Devan Hills Plantation Company Pvt Ltd, KDHP House, Munnar Head Quarters at Munnar.
- 7) CGRF, Cochin Special Economic Zone Authority (CSEZA), Kochi- Head Quarters at Kakkanad.
- 8) CGRF, KINESCO Power Utilities Pvt Ltd (KPUPL), Kochi Head Quarters at Kakkanad.
- 9) CGRF, Rubber Park India Pvt Ltd (RPIL), Ernakulam Head Quarters at Valayanchirangara.
- 10) CGRF, Cochin port Trust, Kochi, Head Quarters at Willingdon Island.

- 11) CGRF, Inforpark, Kochi, Head Quarters at Kakkanad.

Applications are invited from eligible persons for the nomination as of Member (Law) in CGRF Kannan Devan Hills Plantation Company Pvt Ltd (KDHPCL).

As per Regulation 10 (3) of Kerala State Electricity Regulatory Commission (Consumer Grievance Redressal Forum and Electricity Ombudsman) Regulations, 2023, the 3<sup>rd</sup> Member (Law) of the Forum shall be nominated by the Commission for a period of **three years.** The nomination shall be governed by the following terms & conditions.

## 1) Qualifications

- A Bachelor's degree in Law from a recognized University and approved by the Bar Council of India.
- Not less than three years of experience as an Advocate practicing before the Courts/ Forums/ Tribunals in the State of Kerala.
- ➤ Proven ability, integrity, standing and shall have knowledge preferably in electricity related issues and familiarity with consumer affairs and shall be a resident within the area of jurisdiction of the Forum

Provided that no person who is or has been an employee of the distribution licensee shall be nominated by the Commission as Member (Law) of the Forum.

#### 2) Sitting Fee & Other Allowance

The term of office will be three years from the date of nominations. The person nominated shall be entitled for a sitting fee of Rs.2000/- (Rupees Two Thousand Only) per day of sitting. If the sitting is fixed at any place outside the headquarters, TA/DA eligible for Class I Officers of the Government of Kerala from the place of domicile to the place of sitting, apart from sitting fee.

## **General Conditions**

The provisions in the Kerala State Electricity Regulatory Commission (Consumer Grievance Redressal Forum and Electricity Ombudsman) Regulations, 2023 as amended from time to time shall be applicable.

- > The Member nominated by the Commission may be removed from the Forum, after issuance of a notice period of one month at any time, if the Commission is dissatisfied with the performance of the Member.
- > Preference will be given to those applicants who are residents of the District in which the head quarter of the CGRF is situated.
- > The person shall have a working knowledge of Malayalam
- The minimum age limit and upper age limit for nomination shall be 30 years and 62 years as on 01-03-2025.
- $\succ$  The last date for the receipt of applications shall be **04-04-2025**.
- ➤ The Commission reserve the right to cancel/modify this notification at any time without stating any reason whatsoever.
