Educational Qualifications

Graduates in B.Tech/B.E Degree in any of the following disciplines for the Internship Programme of KSERC for the year 2026-27:

- 1) **Computer Science and Engineering (CSE)**
- 2) **Information Technology (IT)**

General Conditions

1. The Internship Programme is strictly for a period of one year.
2. Age Limit: - Upper age limit shall be 23 years as on the date of notification.
3. Eligibility:-
 - a) The candidates who have passed out in first chance only will be considered.
 - b) Proficiency in Malayalam and English is mandatory.
 - c) The candidates should have obtained a minimum mark of 80% or equivalent in 10th and 12th standard.
 - d) The candidates should have secured a minimum CGPA of 7.0 (70 % and above of the total marks in the course) for graduation.
4. The stipend payable shall be Rs 25,000/- (Rupees Twenty Five Thousand Only) per mensem.
5. The application shall be submitted through online mode only.
6. The last date for receipt of applications shall be **at 5.00 P.M on 09-06-2026**

Selection Process

1. The selection will be based on Online Multiple Choice Objective Type Test and a Personal Interview.
2. The Online Multiple Choice Objective Type Test will consist of 100 questions with duration of 90 minutes. There will be negative marks for wrong answers.
3. Questions for the test will be divided into 5 sections as detailed below:-

4. The applicants will be shortlisted for interview based on the marks scored in the online test.
5. Shortlisted candidates alone will be invited for a personal interview.
6. The rank list will be drawn based on the combined score in the online test and personal interview.

8. The application shall be submitted through online mode only using the link available in the website of the Commission (application.kserc.sbs)
